Clarification on issue of lack of official response by the Electoral Commission to the United Seychelles

Thursday 23rd March 2023

On 22nd March 2023, in the National Assembly during the presentation of the Bill to the Elections Act, the Leader of the Opposition, stated that the United Seychelles has not received any response of a letter sent to the Electoral Commission on the 1st of February 2023 in relation to the Bill on the amendment to the Elections Act.

The Commission would like to state the following in regards to the above.

- 1. The Commission received a letter addressed to the Chairperson of the Electoral Commission, dated 6th February 2023 (not dated 1st of February 2023 as referred to by the Leader of the Opposition) The letter was signed by the Secretary General of the United Seychelles Party, Mr. Wallace Cosgrow. (As attached).
- 2. On the 9^{th of} February 2023, a response to the letter was provided to Mr. Cosgrow, on the official email of the United Seychelles, as provided in the letter issued by Mr. Cosgrow, with the following persons in copy:
- The Party Leader: Mr. Patrick HerminieThe Liaison Person: Mr. Melval Dugasse
- 3. The Commission consequently has been made aware that a letter dated 1st of February 2023 by the United Seychelles is being circulated on a social media platform, namely Facebook. The Commission states that it never received any letter from the United Seychelles dated 1st February 2023, as being circulated on social media.

- 1. a copy of the letter issued to the United Seychelles Party dated 23rd March 2023 which clarifies its position with regards to the statement made by the Leader of the Opposition on letter sent on 1st February 2023.

In the Sitting of the National Assembly on 22nd March 2023, the Leader of the Opposition stated that the United Seychelles sent a letter to the Electoral Commission, on the 1st February 2023, to which the party is still awaiting a response. It is to note that the content of the letter, which he stated was sent on the 1st of February 2023 and which was read in the Assembly, had the same content as the one dated 6th February received by the Commission from the Secretary General of the United Seychelles.

The Commission is of the view that the reaction of the Leader of the Opposition vis a vis the letter is a result of a miscommunication, which is outside the scope of the Commission.

The Commission is submitting along with this letter a copy of the letter received from the United Seychelles dated 6th February 2023 and the response of the Commission dated 9th February 2023.

The Commission appreciates the collaborative relationship which exists between the Commission and political parties.

We hope that in future any matters, which the United Seychelles may feel affected by, can be resolved in an amicable manner.

RE: United Seychelles Party position on points discuss during the meeting with political parties

Reference is made to the above mentioned subject and the meeting with political parties held on the 16th of January 2023 at the Headquarters of the Electoral Commission.

Firstly, we have taken note of the proposed Political Parties (Registration and Regulation) (Amendment Bill) in regards to amendments in relation to Business Tax obligations of political parties.

As regards to the Elections (Arnendment Bill) 2022 and the accompanying subsidiary legislation establishing an advisory committee on delimitation of electoral boundaries, we would like to formally express our disappointment in the manner this has been handled. We are of the view that all political parties will be impacted by such amendments to the law and as such there should have been consultations prior to the formulation of the legislations. Furthermore, as stated by our delegation during the meeting, we are of the view that political parties should be represented on the committee and that the Chairperson of the Electoral Commission should not be the chairperson of the committee for reasons of conflict of interest in view that the final proposals will be presented for implementation to the Electoral Commission.

We also discussed on the very important issue of youth (first time voter) registration and as discussed we would like to propose the following for consideration of the Electoral Commission:

- Explore the possibility to re-introduce automatic registration
- Introduce electronic/online registration
